- 4. To accord approval for purchase of 250 MW Solar power from M/s. Giriraj Renewables Pvt. Ltd and 180 MW Solar power from M/s. Shapoorji Pallonji Infrastructure Capital Company Private Limited, if the acceptance to MSEDCL's offer is received from them.
- 5. To consider the submission made by the Petitioner and consider the same positively while deciding the Petition as well as for further actions;
- 6. To pass any other order/relief as the Hon'ble Commission may deem fit and appropriate under the circumstances of the case and in the interest of justice;
- 7. To condone any error/omission and to give opportunity to rectify the same;
- 8. To permit the Petitioner to make further submissions, addition and alteration to this Petition as may be necessary from time to time.
