

NOTICE

Subject: Petition of Maharashtra State Electricity Distribution Co. Ltd. (MSEDCL) for seeking approval on adoption of tariff for long term procurement of 200 MW bagasse based co-generation power under Section 63 of the Electricity Act, 2003 for meeting the non-solar Renewable Purchase Obligations.

- **Case No. 165 of 2018**

Maharashtra State Electricity Distribution Co. Ltd. (MSEDCL) has submitted a Petition on 06.06.2018, for seeking approval on adoption of tariff for long term procurement of 200 MW bagasse based co-generation power under Section 63 of the Electricity Act, 2003 for meeting the non-solar Renewable Purchase Obligations.

The main prayers of the Petitioner are as under-

1. *To admit the Petition as per the provisions of Section 63 of the Electricity Act 2003.*
2. *To accord approval for adoption of tariff as discovered in the e-reverse auction conducted on 29.05.2018.*
3. *To accord approval for purchase of power for capacity of 202.85 MW from the successful bidder for a period of 13 years from Commercial Operation Date (COD) of the plant against tender floated for 200 MW capacity.*
4. *Accordingly, to accord approval for signing of Power Purchase Agreement with the last selected bidder (i.e. Sahakar Maharshi Shivajirao Narayanrao Nagawade SSKL) for its full capacity of 26 MW instead of its partial capacity (restricted due to bucket filling).*
5. *To accord approval for procurement of power from Commercial Operation Date (COD) of the plant at the rates discovered through competitive bidding from already commissioned plants who have given undertaking for synchronization.*
6. *To consider the submission made by the Petitioner and consider the same positively while deciding the Petition as well as for further actions;*
7. *To pass any other order/relief as the Hon'ble Commission may deem fit and appropriate under the circumstances of the case and in the interest of justice;*
8. *Condone any error/omission and to give opportunity to rectify the same;*
9. *To permit the Petitioner to make further submissions, addition and alteration to this Petition as may be necessary from time to time.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Tuesday, 19 June, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the MEDA & the authorised consumer representatives.

4. The Consumer Representatives may submit the say in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, immediately with a copy to the Petitioner.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
