Subject: Petition of Siddhayu Ayurvedic Research Foundation Private Limited review petition under regulation 85 of MERC (Conduct of Business) Regulations, 2004 read with Section 94 (1) (f) of the Electricity Act, 2003 and in the matter of review of part of Order dated 10.04.2018 in Case No. 83 of 2017 and M. A. No. 16 of 2017 passed by the Hon'ble Commission and in the matter of petition of Siddhayu Ayurvedic Research foundation Pvt. Ltd. regarding non-payment of dues by Global Energy Pvt. Ltd. under the EPA dated 20.09.2012.

- **Case No. 141 of 2018**

Siddhayu Ayurvedic Research Foundation Private Limited has submitted a Petition on 10.05.2018 review petition under regulation 85 of MERC (Conduct of Business) Regulations, 2004 read with Section 94 (1) (f) of the Electricity Act, 2003 and in the matter of review of part of Order dated 10.04.2018 in Case No. 83 of 2017 and M. A. No. 16 of 2017 passed by the Hon'ble Commission and in the matter of petition of Siddhayu Ayurvedic Research foundation Pvt. Ltd. regarding non-payment of dues by Global Energy Pvt. Ltd. under the EPA dated 20.09.2012.

The main prayers of the Petitioner are as under-

- a) *Review/modify the observations in para 25 & 26 of the order dated 10.04.2018 passed in Case No. 83 of 2017 and M.A No. 16 of 2017 to the extent as prayed herein.*
- b) *Allow the entire period of claim of the Petitioner irrespective of the date of expiry of the license i.e on 27.09.2012 granted by this Hon'ble Commission;*
- c) *Hold and declare that this Hon'ble Commission has the jurisdiction to entertain the entire claim and not part thereof as the transaction between SARFPL and GEPL was purely intra-state which is further established by the terms of the EPA dated 20.09.2010.*
- d) *Pass such further orders as this Hon'ble Commission deems fit and proper in the interest of justice and good conscience.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Thursday, 05 July, 2018 at 10.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondent and the authorised consumer representatives before the scheduled date of hearing.

4. The Respondent is directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner and authorized Consumer Representatives, the CRs may submit there say before hearing.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
