Subject: Review Petition of Maharashtra State Electricity Distribution Co. Ltd. (MSEDCL) for Review of Order dated 03.04.2018 in Case No. 41 of 2017 passed by the Hon'ble Commission in the matter of Petition of Maharashtra State Electricity Distribution Co. Ltd. for revision in Wind Zone classification of Wind Energy Projects with consistently higher generation.

- **Case No. 152 of 2018**

Maharashtra State Electricity Distribution Co. Ltd. (MSEDCL) has submitted a Review Petition on 18.05.2018, under Regulation 85 of MERC (Conduct of Business) Regulations, 2004 Read With Section 94 (1) (f) of The Electricity Act, 2003 for Review of Order dated 03.04.2018 in Case No. 41 of 2017 passed by the Hon'ble Commission in the matter of Petition of Maharashtra State Electricity Distribution Co. Ltd. for revision in Wind Zone classification of Wind Energy Projects with consistently higher generation.

The main prayers of the Petitioner are as under-

- a) *Review the order dated 03.04.2018 in case no. 41 of 2018 by allowing the present review petition.*
- b) *Revise Wind Zone classification of 42 generators.*
- c) *Devise a procedure to adopt 80 m. hub height (or more) data for Wind power density measurement, to link up actual generation data with Wind Zone classification.*
- d) *To issue directives to MEDA to review the Wind Zone classification of 42 Wind generators & revise them as per the actual generation.*
- e) *To issue direction to MEDA to adopt the methodology suggested by MSEDCL till the procedure to adopt 80 m hub height creation is finalized by MEDA.*
- f) *Pass such further orders as this Hon'ble Commission deems fit and proper in the interest of justice and good conscience.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Tuesday, 26 June, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondents and the authorised consumer representatives before the scheduled date of hearing.

4. The Respondents are directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner and authorized Consumer Representatives, the CRs may submit there say before hearing.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
