Subject: Petition of Maharashtra State Electricity Distribution Co. Ltd.(MSEDCL) under Section 86 (1) (f), (k) and other applicable provisions of the EA, 2003 and in connection with the dispute and differences arising under the standby power agreements dated 13.06.2014, 29.08.2015, 30.06.16 executed between Global Energy Pvt. Ltd. and MSEDCL.

- **Case No. 78 of 2018**

Maharashtra State Electricity Distribution Co. Ltd.(MSEDCL) has submitted a Petition on 09.02.2018 under Section 86 (1) (f), (k) and other applicable provisions of the EA, 2003 and in connection with the dispute and differences arising under the standby power agreements dated 13.06.2014, 29.08.2015, 30.06.16 executed between Global Energy Pvt. Ltd. and MSEDCL.

The main prayers of the Petitioner are as under-

(a) *That the Respondent be ordered and decreed to pay to the Petitioner a sum of Rs.9,82,60,352/- (Rupees Nine Crores Eighty Two Lakhs Sixty Thousand Three Hundred Fifty Two only) as per particulars of claim at Exhibit "EE" with further interest on Rs.6,32,69,488/- (Rupees Six Crores Thirty Two Lakhs Sixty Nine Thousand Four Hundred Eighty Eight only) at the rate of 15% per annum from 31st December 2017 till payment;*

(b) *For cost of the petition;*

(c) *For such other and further reliefs as the nature and circumstances of the case may require,*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Wednesday, 04 July, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondent and the authorised consumer representatives before the scheduled date of hearing.

4. The Respondent is directed to submit its say well in advance on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner and authorized Consumer Representatives.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
