Subject: Petition of M/s. G.I. Energies seeking direction against MSEDCL for banked units of energy from the petitioner's plant within the purview of the Electricity Act, 2003 and Rules thereof read with MERC (RPO, its compliance and implementation of rec framework) Regulations, 2016 and the letter dated September 8, 2017 of MSEDCL.

- **Case No. 120 of 2018**

M/s. G.I. Energies has submitted a Petition on 10.04.2018 under Section 86 (1) (e) of the Electricity Act, 2003 seeking direction against MSEDCL for banked units of energy from the petitioner's plant within the purview of the Electricity Act, 2003 and Rules thereof read with MERC (RPO, its compliance and implementation of rec framework) Regulations, 2016 and the letter dated September 8, 2017 of MSEDCL.

The main prayers of the Petitioner are as under-

- a) *Direct Respondent No. 1 to sign the EPA immediately for purchase of power at preferential tariff for long term basis from April 01, 2015;*
- b) *Direct Respondent No.1 to purchase the wind energy injected by the Petitioner from April 01, 2014 at preferential tariff;*
- c) *Direct Respondent No. 1 to release payment immediately for wind energy injected into the grid of Respondent No.1 from April 01, 2014 till date at preferential tariff along with interest of 15% p.a.;*
- d) *Award costs of this proceeding against the Respondents and in favour of the Petitioner and;*
- e) *Pass such other order(s) as the Hon'ble Commission may deem just in the facts of the present case.*

**Interim prayers -**

- a) *Pass an ad-interim order directing Respondent No. 1 to immediately pay at least 50% of the amount due to the Petitioner for wind energy injected from April 01,2014 by the Petitioner at preferential tariff; and*
- b) *Pass such other order(s) as this Hon'ble Commission may deem just in the facts of the present case.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Thursday, 28 June, 2018 at 10.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondents and the authorised consumer representatives before the scheduled date of hearing.

4. The Respondents are directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner and authorized Consumer Representatives, the CRs may submit there say before hearing.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
