- c. Hold and declare that the observations in the order dated 15.01.2018 passed in Case No. 137 of 2017 shall have prospective applicability from the new financial year;
- d. In the alternative, direct R-Infra to refund the wheeling charges/losses, transmission charges/losses and banking charges alongwith interest @ 18% per annum, illegally recovered by R-Infra on the units on which no banking facility is provided;
- e. Cost of the Petition be awarded in favor of the Petitioners and against R-Infra.
- f. Pass such further order as this Hon'ble Commission may deem fit and proper in the interest of justice and good conscience.
