Subject: Petition of M/s. Gigaplex Estate Private Limited (GEPL) for review of order issued by Hon'ble Commission dated 12th March 2018 in Case No. 149 of 2016 in respect to GEPL's petition for determination of Aggregate Revenue Requirement (ARR) and Tariff for 3rd Control Period from FY 2016-17 to FY 2019-20.

M/s. Gigaplex Estate Private Limited has submitted a Petition on 18.04.2018 for review of order issued by Hon'ble Commission dated 12th March 2018 in Case No. 149 of 2016 in respect to GEPL's petition for determination of Aggregate Revenue Requirement (ARR) and Tariff for 3rd Control Period from FY 2016-17 to FY 2019-20.

- b) *Review the O&M expenses allowed in its Order under the head, "error apparent on the face of the record" or "for any other sufficient reasons" and allow O&M expenses for the 3rd Control Period, from FY 2016-17 to FY 2019-20, based on the actual O&M expenses in FY 2016-17, suitably escalated for each Year of the Control Period.*
- c) *Condone any inadvertent omissions, errors, short comings and permit GEPL to add/change/modify/alter this filing and make further submissions as may be required at a future date; and*
- d) *Pass such other and further Orders as deemed fit and proper in the facts and circumstances of the case.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Friday, 29 June, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
