Subject: Petition of Spentex Industries Limited to amend the provisions of Load Factor Incentive under the Tariff Order.

- **Case No. 158 of 2018**

Spentex Industries Limited has submitted a Petition on 29.05.2018 under the MERC (Supply Code & Other Conditions of Supply) Regulations, 2005 to amend the provisions of Load Factor Incentive under the Tariff Order.

The main prayers of the Petitioner are as under-

- a. *That this Hon'ble Commission may be pleased to amend the provision relating to Load Factor Incentive by deleting the words therein "payment is made within seven days from the date of the bill or within 5 days of the receipt of the bill, whichever is later"*
- b. *Please direct to Respondent to calculate Load factor Incentive on the methodology of payment of Power factor Incentive.*
- c. *Allow the Petitioner to submit any additional information, document and explanation that the Commission may require.*
- d. *Pass such other order or orders as the Hon'ble Commission may deem fit and appropriate.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Saturday, 30 June, 2018 at 10.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondent and the authorised consumer representatives before the scheduled date of hearing.

4. The Respondent is directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner and authorized Consumer Representatives, the CRs may submit there say before hearing.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
