

**NOTICE**

Subject: Petition of Spentex Industries Limited against MSEDCL for Arbitrary Levy of Wheeling Charges & Applicable Wheeling Loss for the Financial Year 2015-2016 and Financial Year 2016-2017.

- **Case No. 159 of 2018**

Spentex Industries Limited has submitted a Petition on 30.05.2018 under Section 142 of the Electricity Act, 2003 against MSEDCL for Arbitrary Levy of Wheeling Charges & Applicable Wheeling Loss for the Financial Year 2015-2016 and Financial Year 2016-2017.

The main prayers of the Petitioner are as under-

- a. *That this Hon'ble Commission may be pleased to declare that the inclusion of levy of Wheeling Charges and applicable wheeling losses in the bills issued for the Period August 2015 till September 2016 by the Respondent is illegal and contrary to MERC (Distribution Open Access) Regulations 2014, 2015 and 2016*
- b. *That this Hon'ble Commission may be pleased to direct the Respondents to refund an amount of Rs.84,53,031 for wheeling charges & an amount of Rs.2,26,87,935 for alleged applicable wheeling losses paid by the Petitioner to Respondents cumulatively amounting to Rs.4,25,75,779 with interest and further interest @18% per annum on Rs.4,25,75,779 till the final payment is made by the Respondents to Petitioner;*
- c. *That this Hon'ble Commission may be pleased to direct that the bills issued by the Respondents for the current month and future bills may be adjusted against refund to be given by the Respondents to Petitioner.*
- d. *That this Hon'ble Commission may be pleased to direct the Respondent No.1 & 2 to not to disconnect the supply of electricity of Petitioner unit at Butibori, Nagpur, Maharashtra, till the refund/adjustment of an amount prayed vide clause 2 of Prayer above is affected.*
- e. *Allow the Petitioner to submit any additional information, document and explanation that the Commission may require.*
- f. *Pass such other order or orders as the Hon'ble Commission may deem fit and appropriate.*

I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Saturday, 30 June, 2018 at 10.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondents and the authorised consumer representatives before the scheduled date of hearing.
4. The Respondents are directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner and authorized Consumer Representatives, the CRs may submit there say before hearing.
5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
