Subject: Petition of Maharashtra State Electricity Distribution Co. Ltd. (MSEDCL) for in principle approval for short term power purchase at higher cost than the ceiling rate approved by Hon'ble Commission.

- **Case No. 176 of 2018**

Maharashtra State Electricity Distribution Co. Ltd. (MSEDCL) has submitted a Petition on 15.06.2018, under Regulation 102 of the MERC (Multi Year Tariff) Regulations, 2015 for in principle approval for short term power purchase at higher cost than the ceiling rate approved by Hon'ble Commission.

The main prayers of the Petitioner are as under-

5.1 To admit the present Petition.

5.2 To accord in principle approval for short term power purchase at higher rate than the ceiling rate approved by Hon'ble commission to meet the demand supply gap as and when required from power exchanges or through short term tenders on DEEP portal.

5.3 To consider the submission made by the Petitioner and consider the same positively while deciding the Petition;

5.4 Considering the facts & circumstances of the case, MSEDCL humbly requests the Hon'ble Commission to conduct early hearing of the present Petition.

5.5 To condone any error/omission and to give opportunity to rectify the same;

5.6 To permit the Petitioner to make further submissions, addition and alteration to this Petition as may be necessary from time to time.

4. The Consumer Representatives to submit there say in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, immediately with a copy to the Petitioner.
