Subject: Petition of Maharashtra State Electricity Distribution Co. Ltd. (MSEDCL) for in principle approval for supplying power during day time to AG consumers connected on AG Feeders of those substations where Solar Power projects gets Commissioned under “Mukhyamantri Sour Krishi Vahini Yojana.”

- **Case No. 178 of 2018**

Maharashtra State Electricity Distribution Co. Ltd. (MSEDCL) has submitted a Petition on 15.06.2018, under Regulation 94 of the MERC (Conduct of Business) Regulations, 2004 for in principle approval for supplying power during day time to AG consumers connected on AG Feeders of those substations where Solar Power projects gets Commissioned under “Mukhyamantri Sour Krishi Vahini Yojana.”

The main prayers of the Petitioner are as under-

- 5.1. *To admit the present Petition.*
- 5.2. *To accord in principle approval for supplying power to Ag consumers connected on Ag feeders of those substations where solar power projects gets commissioned under “Mukhyamantri Sour Krishi Vahini Yojana” for 8 hours during day time i.e. between 08:00 to 18:00 hours with stagger time slots.*
- 5.3. *To consider the submission made by the Petitioner and consider the same positively while deciding the Petition;*
- 5.4. *Considering the facts & circumstances of the case, MSEDCL humbly requests the Hon’ble Commission to conduct early hearing of the present Petition.*
- 5.5. *To condone any error/omission and to give opportunity to rectify the same;*
- 5.6. *To permit the Petitioner to make further submissions, addition and alteration to this Petition as may be necessary from time to time.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Saturday, 30 June, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the authorised consumer representatives before the scheduled date of hearing.

4. The Consumer Representatives to submit there say in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, immediately with a copy to the Petitioner.
