Subject: Petition of Dhariwal Industries Limited & Anr under Section 86 (1) (d) and Section 86 (1) (k) seeking direction to Global Energy Private Limited (Trading Licensee) to honor the terms of the EPA entered between the Petitioners and Respondent and to release the admitted outstanding payments immediately alongwith interest.

- **Case No. 160 of 2018**

Dhariwal Industries Limited & Anr has submitted a Petition on 31.05.2018 under Section 86 (1) (d) and Section 86 (1) (k) seeking direction to Global Energy Private Limited (Trading Licensee) to honor the terms of the EPA entered between the Petitioners and Respondent and to release the admitted outstanding payments immediately alongwith interest.

The main prayers of the Petitioner are as under-

1. *Direct the Respondent to immediately pay an amount of Rs. 6,25,16,019/- on account of the principal sum for the power being supplied under the EPA.*
2. *Direct the Respondent to immediately pay an amount of Rs. 7,37,68,903/- on account of interest pending till date on the principal outstanding amount.*
3. *Exercise powers under Section 32 of the Maharashtra Electricity Regulatory Commission (Conduct of Business) Regulations, 2004 and initiate an enquiry in the conduct, manner and modus-operandi of the Respondent's functioning.*
4. *Revoke the Trading License bearing No. 01 of 2018 dated 27.04.2018, issued to the Respondent.*
5. *Fix trading margins for Intra-State trading of electricity.*
6. *Grant a sum of Rs. 1 Crore towards damages, loss of reputation, mental agony and cost of the present Petition.*
7. *Pass such further orders as this Hon'ble Commission deems fit and proper in the interest of justice and good conscience.*

2. 3. The Petitioners are directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondent and the authorised consumer representatives before the scheduled date of hearing.
4. The Respondent is directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioners and authorized Consumer Representatives, the CRs may submit there say before hearing.
5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
