

NOTICE

Subject: Petition of RattanIndia Power Ltd. for Power Purchase Agreement between RPL and MSEDCL for 1200 MW and for issue of directions to MSLDC to accept and schedule the declared capacity of up to 258 MW for all 5 units of Amravati TPS.

- **Case No. 59 of 2018**

RattanIndia Power Limited has submitted a Petition on 23.01.2018 under Section 32, 33 & 86 of the Electricity Act, 2003 for Power Purchase Agreement between RPL and MSEDCL for 1200 MW and for issue of directions to MSLDC to accept and schedule the declared capacity of up to 258 MW for all 5 units of Amravati TPS.

The main prayers of the Petitioner are as under-

- (a) *direct the Respondent No. 1 to permit scheduling and delivery of up to 258 MW / Unit for all the 5 units of Amravati TPS;*
- (b) *direct the Respondent No. 1 to dispatch the Amravati TPS in accordance with the capacity as declared by the Petitioner from time to time;*
- (c) *direct the Respondent No. 2 to pay full Capacity Charges for invoices raised from September 2017 onwards based on the Availability Declaration of 258 MW / Unit for the 5 Units of Amravati TPS;*
- (d) *direct the Respondent No. 2 to pay interest on the delay in payment of Capacity Charges in accordance with Article 8.3.5 of the PPAs;*
- (e) *direct the Respondent No. 2 to make payment of Capacity Charges in future on the basis of increased Ex-bus capacity declarations (i.e., up to 258 MW / Unit) made by the Petitioner from time to time; and*
- (f) *pass any such further or other orders as this Hon'ble Commission may deem just and proper.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Thursday, 05 July, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondents and the authorised consumer representatives before the scheduled date of hearing.

4. The Respondents are directed to submit its say well in advance on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner and authorized Consumer Representatives.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
