M/s Navjeevan Hybrid Seeds Corporation has submitted a Petition on 07.05.2018 under Section 142 & 146 of Electricity Act, 2003 for non compliance of Hon'ble Commission Order dt. 09.12.2016 in Case No. 04/2015.

The main prayers of the Petitioner are as under-

1. *The petition may be allowed.*
2. *Respondent may be directed to reconnect the electricity supply of the petitioner immediately.*
3. *Respondent may be directed to comply the order dt. 09.12.2016 passed by Hon'ble Commission in case No. 04/2015.*
4. *Respondent may be directed to issue revise bill without levying interest and Delay payment charges etc.*
5. *Respondent may be directed to pay Rs. 25000/ for illegally disconnecting electricity supply and removing meter of the petitioner.*
6. *Respondents may be directed to pay compensation of Rs. 50000/ towards cost of filing this petition, mental harassment, travelling etc.*
7. *Respondent may be directed to pay Rs. 1, 00,000/ towards non compliance of Hon'ble Commission order dt. 09.12.2016*
8. *Any other relief as deemed fit by Hon'ble Commission.*

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
