- c) We also request Hon'ble Commission to give directive to concerned officer i.e Executive engineer Thane to comply CGRF Order or register our case as per provision of law u/s/142 & 146 E.A.2003 for non compliance of Hon'ble C.G.R.F. order.
- d) It is also prayed that the compensation to the applicant be allowed for the harassment and compelling the applicant to carry out the work on his own by shirking away the direction of the Hon'ble CGRF order.
