Subject: Petition of M/s. Sandeep Dwellers Pvt. Ltd. for directing MSEDCL and/or its franchisee at Nagpur M/s. SND Limited, to Comply Hon. Ombudsman's Order No. 34/2017 passed on 28th July, 2017 and Review Petition Order No. 3/2017 passed on 6th Mar, 2018.

- **Case No. 177 of 2018**

M/s. Sandeep Dwellers Pvt. Ltd. has submitted a Petition on 07.05.2018 under Section 142 and 149 of the Electricity Act, 2003 for directing MSEDCL and/or its franchisee at Nagpur M/s. SND Limited, to Comply Hon. Ombudsman's Order No. 34/2017 passed on 28th July, 2017 and Review Petition Order No. 3/2017 passed on 6th Mar, 2018.

The main prayers of the Petitioner are as under-

1. *Fore with implementation of Order passed on 28th July 17 by Hon. Electricity Ombudsman, Nagpur in case no. 34/2017*
2. *The Hon. Commission may initiate proceedings under Section 142 and 149 of the Electricity Act, 2003 against the responsible officers of MSEDCL / distribution licensee for non-compliance of Hon. Electricity Ombudsman's order dated 28th July 17.*
3. *The Hon. Commission may please grant relief for the mental harassment / torture that it has caused to the petitioner.*
4. *The Hon. Commission may please direct MSEDCL / distribution licensee to compensate the cost of this petition (as deemed fit).*
5. *The Hon. Commission may please grant the liberty to change / add / modify this petition and make further submissions as may be required in future date.*
6. *The Hon. Commission may please provide any other equitable relief as deemed fit, may be granted in the interest of justice for effective adjudication of the matter involved in this petition for its implementation.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Saturday, 07 July, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondent and the authorised consumer representatives before the scheduled date of hearing.

4. The Respondent is directed to submit its say well in advance on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner and authorized Consumer Representatives.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
