Subject: Petition of Shri Vishnu Ramdas Chavan against MSEDCL under Section 142 of Electricity Act, 2003 and under Regulation 22 of MERC (CGRF) Regulations, 2006. Disconnection of Electricity supply without Notice as per Section 56(1) Electricity Act, of 2003.

- **Case No. 117 of 2018**

Shri Vishnu Ramdas Chavan has submitted a Petition on 13.04.2018, under Section 142 of Electricity Act, 2003 and under Regulation 22 of MERC (CGRF) Regulations, 2006. Disconnection of Electricity supply without Notice as per Section 56(1) Electricity Act, of 2003.

The main prayers of the Petitioner are as under-

- १) विदयुत कायदा २००३ चे कलम ५६ (१) चा भंग केल्याबाबत उत्तरार्थी नं. १ यांना दंड किंवा शिस्तभंगाची कार्यवाही करण्यात यावी.

- ३) विदयुत कायदा २००३ चे कलम १५१ प्रमाणे १३५ खाली उत्तरार्थी नं. ३ यांना कायदेशीर अधिकार आहेत काय ? याबाबतचा स्पष्ट आदेश देण्यात यावे.
- ४) विदयुत कायदा २००३ चे कलम १५२ (२) चा भंग केल्याबाबत अब्रुनुकसानी व मानहानी म्हणून उत्तरार्थी नं. ३ यांचेकडून रक्कम रुपये १०,००,०००/- देण्याचा हुकूम व्हावा.
- ५) उत्तरार्थीकडून या तक्रार अर्जाचा खर्च उत्तरार्थी कडून देण्यात यावा.

4. The Respondents are directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner and authorized Consumer Representatives, the CRs may submit there say before hearing.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
