- 1. The Tata Power Company Limited (Tata Power-T) has filed a Mid Term Review (MTR) Petition for 3rd control period for approval of Truing up of Aggregate Revenue Requirement (ARR) for FY 2015-16 and FY 2016-17, Provisional Truing up of FY 2017-18 and approval of revised ARR for FY 2018-19 and FY 2019-20. The filing for Truing up for FY 2015-16 is based on applicable provisions of MERC (Multi Year Tariff) Regulations, 2011. The filing for Truing up for FY 2016-17, Provisional Truing up of FY 2017-18 and revised ARR for FY 2018-19 and FY 2019-20 is based on applicable provisions of MERC (Multi Year Tariff) Regulations, 2015 and other relevant Regulations.
