

**NOTICE**

Subject: Petition of Sai Wardha Power Generation Limited for seeking declaration of compliance of captive status with respect to the generating units of 2x135 MW of the Petitioner, Sai Wardha Power Generation Limited for the financial year 2017-18.

- **Case No. 170 of 2018**

Sai Wardha Power Generation Limited has submitted a Petition on 13.06.2018, under Section 42 of Electricity Act 2003 for seeking declaration of compliance of captive status with respect to the generating units of 2x135 MW of the Petitioner, Sai Wardha Power Generation Limited for the financial year 2017-18.

The main prayers of the Petitioner are as under-

*(a) Hold and declare the captive generating units (2x 135 MW being Unit No. 3 and Unit No. 4) of the Petitioner have complied with the obligations attached to the captive generating units in terms of Rule 3 of the Electricity Rules, 2005 for the FY 2017-18.*

*(b) Hold and declare that the Petitioner and its captive consumers are entitled to all benefits of CPP and captive consumption including exemption from payment of Cross Subsidy Surcharge and other related charges for the FY 2017-18.*

*(c) Pass any such further order(s) that the Hon'ble Commission may deem just in the facts of the present case.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Wednesday, 19 September, 2018 at 10.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

2. I am directed to communicate that; the Commission has impleaded Maharashtra State Electricity Transmission Company (MSETCL) as parties in the matter.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondents and Impleaded party MSETCL before the scheduled date of hearing.

4. The Respondents and Impleaded party MSETCL are directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
