Subject: Petition of M/s. Bhilwara Green Energy Limited under section 86 (1) (f) of the Electricity Act, 2003 filed on behalf of M/s. Bhilwara Green Energy Limited for release of the total amount due and payable to it by MSEDCL for supply of wind energy as per the provision of the various Wind Energy Purchase Agreements entered into between the parties.

- **Case No. 222 of 2018**

M/s. Bhilwara Green Energy Limited has submitted a Petition on 30.07.2018 under section 86 (1) (f) of the Electricity Act, 2003 filed on behalf of M/s. Bhilwara Green Energy Limited for release of the total amount due and payable to it by MSEDCL for supply of wind energy as per the provision of the various Wind Energy Purchase Agreements entered into between the parties.

The main prayers of the Petitioner are as under-

- a) *Direct the Respondent to pay the Principal Amount along with Late Payment Surcharge of Rs. 51,39,78,849/- (Rupees Fifty One Crores Thirty Nine Lakhs Seventy Eight Thousand Eight Hundred and Forty Nine only) i.e. the Due Amount for supply of wind energy as per the terms of the WEPAs;*
- b) *Direct the Respondent to pay carrying cost at the rate of 15% per annum of the delay in payment of the late payment surcharge by the Respondent;*
- c) *Direct the Respondent to remit the amounts due and payable on time, as per the terms of the WEPAs;*
- d) *Direct the Respondent to pay the costs of the present Petition;*
- e) *Condone any inadvertent omissions / errors / shortcomings and permit the Petitioner to add/change/modify/alter this filing and make further submissions as may be required at a future date;*
- f) *Pass such other order(s) as this Hon'ble Commission may deem fit and proper in the facts and circumstances of the case.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Monday, 22 October, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondent before the scheduled date of hearing.

4. The Respondent is directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner.
5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
