Subject: Petition of Hindustan Petroleum Corporation Limited under Section 86 (1)(f) of the Electricity Act, 2003 pertaining to adjudication of disputes between Hindustan Petroleum Corporation Limited and MSEDCL.

- **Case No. 223 of 2018**

Hindustan Petroleum Corporation Limited has submitted a Petition on 02.08.2018 under Section 86 (1)(f) of the Electricity Act, 2003 pertaining to adjudication of disputes between Hindustan Petroleum Corporation Limited and MSEDCL.

The main prayers of the Petitioner are as under-

- a. *Direct the Respondent to make payment for the wind energy generated by the Petitioner regularly and in timely manner as per the WEPA;*
- b. *Direct MSEDCL to make payment of the outstanding amount towards Sales Invoices due till date within seven (7) days [a sum of Rs. 2,28,82,069.00 (Rupees Two Crore Twenty Eight Lakhs Eighty Two Thousand and Sixty Nine Only) is due as on June 30, 2018 as detailed in Annex D];*
- c. *Direct MSEDCL to make payment of the outstanding amount towards DPC as per the WEPA due till date within seven (7) days [a sum of Rs. 68,03,597.00 (Rupees Sixty Eight Lakhs Three Thousand Five Hundred and Ninety Seven Only) is due as on June 30, 2018 as detailed in Annex D];*
- d. *Direct Respondent to issue credit notes within fifteen (15) days generation and comply with the Citizen Charter to enable the Petitioner to issue invoices under the WEPA in a timely manner;*
- e. *Direct the Respondent to pay carrying cost at the rate of 15% per annum of the delay in payment of the late/delayed payment surcharge by the Respondent;*
- f. *Award costs of these proceedings against MSEDCL and in favour of the Petitioner; and*
- g. *Pass such other order(s) as the Hon'ble Commission may deem just in the facts of the present case."*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Friday, 12 October, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondent before the scheduled date of hearing.
4. The Respondent is directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner.
5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
