Ltd & Ors under Section 19 of the Electricity Act for revocation of Trading License bearing No. 01 of 2018 dated 27.04.2018 issued to Global Energy Private Limited by this Hon'ble Commission and in the matter of Violation of the trading license condition issued by this Hon'ble Commission vide Trading License bearing No. 01 of 2018 dated 27.04.2018.

POSCO Maharashtra Steel Pvt. Ltd & Ors has submitted a Petition on 21.08.2018 under Section 19 of the Electricity Act for revocation of Trading License bearing No. 01 of 2018 dated 27.04.2018 issued to Global Energy Private Limited by this Hon'ble Commission and in the matter of Violation of the trading license condition issued by this Hon'ble Commission vide Trading License bearing No. 01 of 2018 dated 27.04.2018.

The main prayers of the Petitioner are as under-

1. *Revoke the Trading License bearing No. 01 of 2018 dated 27.04.2018, issued to the Global Energy Private Limited.*
2. *Exercise powers under Section 32, 33 & 34 of the Maharashtra Electricity Regulatory Commission (Conduct of Business) Regulations, 2004 and initiate an enquiry in the conduct, manner and modus-operandi of the Respondent's functioning in view of the revelations in the present Petition.*
3. *Pass such further orders as this Hon'ble Commission deems fit and proper in the interest of justice and good conscience.*
