

**NOTICE**

Subject: Petition of Brihanmumbai Electric Supply and Transport Undertaking (BEST) under Section 86 (1) (b) of Electricity Act, 2003 to regulate electricity purchase and procurement process of distribution licensees including the price at which electricity shall be procured from the generating companies or licensees or from other sources through agreements for purchase of power for distribution and supply within the State.

- **Case No. 249 of 2018**

Brihanmumbai Electric Supply and Transport Undertaking (BEST) has submitted a Petition on 23.08.2018 under Section 86 (1) (b) of Electricity Act, 2003 to regulate electricity purchase and procurement process of distribution licensees including the price at which electricity shall be procured from the generating companies or licensees or from other sources through agreements for purchase of power for distribution and supply within the State.

The main prayers of the Petitioner are as under-

- a) *Allocate TPC Hydro power to BEST and TPC in appropriate ratio as discussed in para. 5 above for now and in future.*
- b) *Approve BEST's proposal as per para. 7.0 above.*
- c) *Allow BEST to cancel Bid II & Bid III.*
- d) *Condone any inadvertent omission / errors and grant the liberty to BEST to add/ change/ modify /alter this submission and make further submissions as may be required at a future date;*
- e) *Pass such further and other orders, as the Hon'ble Commission may deem fit and proper, keeping in view the facts and circumstances of the case.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Monday, 24 September, 2018 at 10.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the impleaded party TPC before the scheduled date of hearing.

4. The impleaded party TPC is directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner.
