Subject: Petition of Mahati Hydro Power Projects Private Limited against non-compliance by Maharashtra State Electricity Transmission Company Limited of the Order dated April 10, 2018 of the Hon'ble Commission read with relevant provisions of the Electricity Act, 2003 in Case No. 52 of 2017.

- **Case No. 194 of 2018**

Mahati Hydro Power Projects Private Limited has submitted a Petition on 27.06.2018 under Section 142, 146 and 149 of the Electricity Act, 2003 against non-compliance by Maharashtra State Electricity Transmission Company Limited of the Order dated April 10, 2018 of the Hon'ble Commission read with relevant provisions of the Electricity Act, 2003 in Case No. 52 of 2017.

The main prayers of the Petitioner are as under-

- a) *This Hon'ble Commission be pleased to direct the Respondent No. 1 to forthwith comply with the Order dated April 10, 2018 and pay the Petitioner in compliance of the Order dated April 10, 2018 in Case No. 52 of 2017 [detailed calculation is provided in the excel sheet annexed as Annex "B"];*
- b) *This Hon'ble Commission be pleased to direct the Respondent No. 1 to forthwith pay the Petitioner interest @ 18% p.a. on amount payable till date of payment;*
- c) *This Hon'ble Commission be pleased to initiate proceedings against the Respondent No. 1 and its officers under provisions of the EA 2003 including sections 142 and 146 of the EA 2003, for willful disobedience and for securing compliance of the Orders passed by the Hon'ble Commission;*
- d) *This Hon'ble Commission be pleased to refer the matter to the Hon'ble High Court for initiation of contempt proceedings against the Respondents No. 1's directors and officers;*
- e) *This Hon'ble Commission be pleased to order Interim and Ad-interim reliefs in terms of prayers (a) to (b) above;*
- f) *This Hon'ble Commission be pleased to award cost for these proceedings against Respondent No. 1 and in favour of the Petitioner;*
- g) *This Hon'ble Commission be pleased to pass such other orders as this Hon'ble Commission may deem fit.*

2. I am directed to communicate that the hearing in the above matter will be held on **Thursday, 27 September, 2018 at 10.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
