Subject: Review Petition of Maharashtra State Electricity Transmission Co. Ltd. seeking review of the MERC Order dated 02.05.2018 passed in Case No. 112 of 2017, Petition filed by the M/S. Olam Agro India Private Limited.

- **Case No. 201 of 2018**

Maharashtra State Electricity Transmission Co. Ltd. has submitted a Review Petition on 27.06.2018 under Section 94(1)(f) of the Electricity Act, 2003 seeking review of the MERC Order dated 02.05.2018 passed in Case No. 112 of 2017, Petition filed by the M/S. Olam Agro India Private Limited.

The main prayers of the Petitioner are as under-

- a. *This Hon'ble Commission be pleased to recall the order dated 2.05.2018 passed in Case No.112 of 2017 and restore the Case No.112 of 2017 to its original file and rehear the case as to the liability of the licensee as per the GOM policy of 2008 and the Procedure of 2010.*
- b. *This Hon'ble Court be pleased to modify the order dated 2.05.2018 passed in Case No.112 of 2017 and thereby direct the payment to Original Petitioner 50% by MSETCL and 50% by MEDA as per the GOM Policy of 2008 and Procedure of 2010.*
- c. *Pending hearing and final disposal of this Review Petition, this Hon'ble Commission be pleased to stay the operation and implementation of the order dated 2.05.2018 passed in Case No.112 of 2017.*
- d. *This Hon'ble Commission be pleased to grant any other relief in favour of the Petitioner as the Commission may deem fit.*
