Subject: Petition of Asian Hotel (West) Limited Review of Order dated 09.07.2018 passed in Case No. 166 of 2018 by the Hon'ble Commission.

- **Case No. 208 of 2018**

Asian Hotel (West) Limited has submitted a Petition on 12.07.2018 under Section 94 (f) of the Electricity Act, 2003 Review of Order dated 09.07.2018 passed in Case No. 166 of 2018 by the Hon'ble Commission.

The main prayers of the Petitioner are as under-

- (a) *Review the order dated 09.07.2018 passed in Case No. 166 of 2018 to the extent as prayed herein;*
- (b) *Hold and declare that the Petitioner being a captive consumer is not liable to pay the CSS component which is subsumed in RAC;*
- (c) *Hold and declare that the Petitioner is liable to pay the RAC only to the extent of wheeling component subsumed in RAC as the Petitioner is connected to the Distribution system of the Respondent and;*
- (d) *Pass such further orders as this Hon'ble Commission deems fit and proper in the interest of justice and good conscience.*
