Subject: Petition of Pravin Mormukut Brijwasi, as partner Rajyog Group Venture & Others for regarding Violation by MSEDCL of Supply Code Regulations and in the matter of the Order of Assessment dated 30/05/2018.

- **Case No. 202 of 2018**

Pravin Mormukut Brijwasi, as partner Rajyog Group Venture & Others has submitted a Petition on 28.06.2018 under Section 135 and 152 of the Electricity Act, 2003 regarding Violation by MSEDCL of Supply Code Regulations and in the matter of the Order of Assessment dated 30/05/2018.

The main prayers of the Petitioner are as under-

- A. *The order of assessment dated 28/05/2018 and the bill generated in respect of consumer no. 590010082317 may kindly be set aside.*
- B. *Directions may please be issued to revise the assessment time period read with regulation 8.6 of supply code 2005*
- C. *Action under section 142 of EA 2003 may please be initiated against Flying Squad Osmanbad (Urban) for violating provisions of supply code 2005 & terms and conditions of supply and for issuing arbitrary assessment for period of 24 months without recording justification of period taken into consideration for the purpose of assessment.*
- D. *Directions may please be issued to reassess and thereby assessment may please be rectified.*
- E. *pending hearing and final disposal this appeal the impugned order to the extent compounding charges may kindly be stayed in the interest of justice.*
- F. *Any other relief in favour of petitioner which Hon'ble Commission/Forum may deem fit considering fact and circumstances of the case including cost.*
