Subject: Petition of Jayesh Purushottam Patel under Section 86(1)(f) of the Electricity Act, 2003 pertaining to adjudication of disputes between Jayesh Purushottam Patel and Maharashtra State Electricity Distribution Company Limited.

- **Case No. 195 of 2018**

Jayesh Purushottam Patel has submitted a Petition on 27.06.2018 under Section 86(1)(f) of the Electricity Act, 2003 pertaining to adjudication of disputes between Jayesh Purushottam Patel and Maharashtra State Electricity Distribution Company Limited.

The main prayers of the Petitioner are as under-

- a) *Direct MSEDCL to make payment of the Outstanding Amount towards Sales Invoices due within seven (7) days [a sum of Rs.1,06,03,419/- (Rupees One Crore Six Lakh Three Thousand Four Hundred Nineteen only) is due for a period from April 01, 2017 till March 31, 2018 as detailed in Annex D];*
- b) *Direct MSEDCL to make payment of the Outstanding Amount towards DPC due as per the WEPAs [a sum of Rs.31,11,360/- (Rupees Thirty One Lakh Eleven Thousand Three Hundred Sixty only) is outstanding DPC for Panchpatta Project and Satara Project as on April 30, 2018 as also detailed in Annex D];*
- c) *Direct MSEDCL to honour terms of WEPAs in letter and spirit and keep paying dues as and when payable;*
- d) *Direct the Respondent to pay carrying cost at the rate of 15% per annum of the delay in payment of DPC by the Respondent;*
- e) *Award costs of these proceedings against MSEDCL and in favour of the Petitioner; and*
- f) *Pass such other order(s) as the Hon'ble Commission may deem just in the facts of the present case.*

2. I am directed to communicate that the hearing in the above matter will be held on **Tuesday, 25 September, 2018 at 10.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondent before the scheduled date of hearing.

4. The Respondent is directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner.
5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
