

NOTICE

Subject: Petition of Sahyadri Industries Limited under Section 86(1)(f) of the Electricity Act, 2003 pertaining to adjudication of disputes between Sahyadri Industries Limited and Maharashtra State Electricity Distribution Company Limited.

- **Case No. 199 of 2018**

Sahyadri Industries Limited has submitted a Petition on 27.06.2018 under Section 86(1)(f) of the Electricity Act, 2003 pertaining to adjudication of disputes between Sahyadri Industries Limited and Maharashtra State Electricity Distribution Company Limited.

The main prayers of the Petitioner are as under-

- a. *Direct the Respondent to make payment for the wind energy generated by the Petitioner regularly and in timely manner as per all the WEPAs;*
- b. *Direct MSEDCL to make payment of all the outstanding amount towards Sales Invoices due within seven (7) days [a sum of Rs.6,01,38,697.57/- (Rupees Six Crores One Lakh Thirty Eight Thousand Six Hundred Ninety Seven and Fifty Seven Paise only) is due for period from April 1, 2017 till March 30, 2018 as detailed in Annex K];*
- c. *Direct MSEDCL to make payment of the outstanding amount towards DPC dues as per the WEPAs [a sum of Rs.2,10,06,248.87/- (Rupees Two Crores Ten Lakhs Six Thousand Two Hundred Forty Eight and Eighty Seven Paise only) is due as on April 30, 2018 as detailed in Annex K];*
- d. *Direct MSEDCL to pay the Petitioner an amount of Rs.82,98,069.48/- (Rupees Eighty Two Lakh Ninety Eight Thousand Sixty Nine and Forty Eight Paise only) towards the invoices raised for the sale of power to MSEDCL for the period from March 2017 to August 2017 as detailed in Annex R along with interest @15% per annum from due date till payment or realization thereof;*
- e. *Direct MSEDCL to pay the Petitioner interest on amount towards banked units, over injected units and wind power sold to MSEDCL amounting to Rs.8,47,499/- (Rupees Eight Lakh Forty Seven Thousand Four Hundred Ninety Nine Only) [as per Annex S];*
- f. *Direct the Respondent to pay carrying cost at the rate of 15% per annum for the delay in payment of the DPC as well as interest on amount towards banked units, over injected units and sale of power to the Respondent;*
- g. *Award costs of these proceedings against MSEDCL and in favour of the Petitioner; and*
- h. *Pass such other order(s) as the Hon'ble Commission may deem just in the facts of the present case.*

2. I am directed to communicate that the hearing in the above matter will be held on **Friday, 28 September, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.
3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondent before the scheduled date of hearing.
4. The Respondent is directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner.
5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
