Subject: Petition of Wali Mohammed S/o Abdul Aziz under Section 67 (4) of Electricity Act, 2003 R/W Rule 13 of The Maharashtra Electricity Works of Licensee Rules 2012, seeking proper compensation towards the erection of Transmission Line Tower in the Petitioner's Land by MSETCL.

- **Case No. 215 of 2018**

Wali Mohammed S/o Abdul Aziz has submitted a Petition on 24.07.2018 under Section 67 (4) of Electricity Act, 2003 R/W Rule 13 of The Maharashtra Electricity Works of Licensee Rules 2012, seeking proper compensation towards the erection of Transmission Line Tower in the Petitioner's Land by MSETCL.

The main prayers of the Petitioner are as under-

a) *The application may be allowed.*

b) *The petitioner may kindly be allowed the amount of compensation, solatium and rent as prayed before the District Collector, Akola and / or the District Collector, Akola may kindly be directed to decide the quantum of compensation, solatium and rent considering all facts and considering the proper and fair valuation of the land, crops and trees.*

c) *The petitioner prays that the MSETCL may be penalized for non-compliance of the provisions of Electricity Act according to section 67 (5) of E. Act 2003 and the penal compensation may be awarded to the Petitioner.*

d) *That the petition may be allowed with cost and the respondents be ordered and directed to pay costs of Rs. 15,000/- to the petitioner.*

e) *All other just and equitable reliefs be granted for the effective adjudication of the subject matter involved in this petition and for its implementation.*

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
