Subject: Petition of Jewelex India Private Limited under Section 86(1)(f) of the Electricity Act, 2003 seeking directions from the Hon'ble Commission to MSEDCL for payment of outstanding bills immediately alongwith delayed payment charges and interest accrued thereupon and other remedies and petition requesting the Hon'ble Commission to issue necessary directions to MSEDCL to honor the terms and conditions of article 12 of the Energy Purchase Agreement dated 24.04.2006 entered between the Petitioner and the Respondent .

- **Case No. 232 of 2018**

Jewelex India Private Limited M/s Silverline Investment Company Pvt. Ltd. has submitted a Petition on 13.08.2018 under Section 86(1)(f) of the Electricity Act, 2003 seeking directions from the Hon'ble Commission to MSEDCL for payment of outstanding bills immediately alongwith delayed payment charges and interest accrued thereupon and other remedies and petition requesting the Hon'ble Commission to issue necessary directions to MSEDCL to honor the terms and conditions of article 12 of the Energy Purchase Agreement dated 24.04.2006 entered between the Petitioner and the Respondent.

The main prayers of the Petitioner are as under-

- a) *Direct MSEDCL to release the outstanding payments forthwith and no later by 30 days in accordance with Section 12.02 of the EPAs;*
- b) *Direct MSEDCL to pay the Delayed Payment Charges (DPC) due on the outstanding bills immediately in accordance with Section 12.02 of the EPAs;*
- c) *Hold and declare that in addition to the above, an interest @ 18% per annum is applicable on the payments as and when to be made by MSEDCL;*
- d) *Cost of the petition as this Hon'ble Commission deems fit and proper;*
- e) *Direct MSEDCL to permit the Petitioner to set off captive power consumption against the power procured by the Petitioner from Reliance Infrastructure Limited;*
- f) *Pass such further orders as this Hon'ble Commission deems fit and proper in the interest of justice and good conscience.*

2. I am directed to communicate that the hearing in the above matter will be held on **Tuesday, 30 October, 2018 at 10.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondent before the scheduled date of hearing.
4. The Respondent is directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner.
5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
