Subject: Petition of Neha Sharma against the MSEDCL seeking the kind indulgence of this Hon'ble Commission in directing MSEDCL to comply with Article 10.05 of the EPA dated 21.03.2017 and pay the outstanding amounts to the Applicants alongwith Late Payment Surcharge ("LPS") and interest accrued thereupon.

- **Case No. 236 of 2018**

Neha Sharma has submitted a Petition on 14.08.2018 against the MSEDCL seeking the kind indulgence of this Hon'ble Commission in directing MSEDCL to comply with Article 10.05 of the EPA dated 21.03.2017 and pay the outstanding amounts to the Applicants alongwith Late Payment Surcharge ("LPS") and interest accrued thereupon.

The main prayers of the Petitioner are as under-

- a) *Direct MSEDCL to releases the outstanding payments forthwith and no later by 30 days in accordance with Article 10.05 of the EPA;*
- b) *Direct MSEDCL to pay the Late Payment Surcharge (LPS) due on the outstanding bills immediately in accordance with Article 10.05 of the EPA;*
- c) *Direct that in addition to the above, an interest @ 18% per annum is applicable on the payments as and when to be made by MSEDCL;*
- d) *Pass such further orders as this Hon'ble Commission deems fit and proper in the interest of justice and good conscience."*

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
