Subject: Petition of Baidyanath Power Private Limited against the MSEDCL seeking the kind indulgence of this Hon'ble Commission in directing MSEDCL to comply with Article 11.04 and 12.02 of the Energy Purchase Agreement entered between the Applicant and the Respondent. (Late Payment Surcharge)

- **Case No. 237 of 2018**

Baidyanath Power Private Limited has submitted a Petition on 14.08.2018 against the MSEDCL seeking the kind indulgence of this Hon'ble Commission in directing MSEDCL to comply with Article 11.04 and 12.02 of the Energy Purchase Agreement entered between the Applicant and the Respondent. (Late Payment Surcharge)

The main prayers of the Petitioner are as under-

- a) *Direct MSEDCL to releases the outstanding payments forthwith and no later by 30 days in accordance with Article 11.04 & 12.02 of the EPA;*
- b) *Direct MSEDCL to pay the Late Payment Charges (LPS) due on the outstanding bills immediately in accordance with Article 11.04 & 12.02 of the EPA;*
- c) *Direct that in addition to the above, an interest @ 18% per annum is applicable on the payments as and when to be made by MSEDCL;*
- d) *Pass such further orders as this Hon'ble Commission deems fit and proper in the interest of justice and good conscience."*

2. I am directed to communicate that the hearing in the above matter will be held on **Tuesday, 30 October, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

4. The Respondent is directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
