Subject: Petition of Jawahar Shetkari Sahakari Sakhar Karkhana Ltd., for clarification of Order dated 12th July, 2018 passed by Hon'ble Commission in MERC case No. 84 of 2015.

- **Case No. 225 of 2018**

Jawahar Shetkari Sahakari Sakhar Karkhana Ltd., has submitted a Petition on 06.08.2018 for clarification of Order dated 12th July, 2018 passed by Hon'ble Commission in MERC case No. 84 of 2015.

The main prayers of the Petitioner are as under-

- (a) *To declare that the tariff applicable for energy supplied by Applicant to MSEDCL during FY 2014-15 (1st April 2014 to 9th November 2015) shall be Rs. 4.47 per unit and give further directions to MSEDCL to pay balance amount to the Applicant.*
- (b) *To declare that the tariff applicable for energy supplied by Applicant to MSEDCL during FY 2015-16 (10th November 2015 to 31st March 2016) shall be Rs. 4.73 per unit and give further directions to MSEDCL to pay balance amount to the Applicant.*
- (c) *To declare that the tariff applicable for energy supplied by Applicant to MSEDCL during FY 2016-17 (1st April 2016 to 31st March 2017) shall be Rs. 4.93 per unit and give further directions to MSEDCL to pay balance amount to the Applicant.*
- (d) *To declare that the tariff applicable for energy supplied by Applicant to MSEDCL during FY 2017-18 (1st April 2017 to 31st July 2018) shall be Rs. 4.64 per unit and give further directions to MSEDCL to pay balance amount to the Applicant.*
- (e) *To approve the interim tariff energy supplied by Applicant to MSEDCL during FY 2018-19 at the rate of Rs. 3.98 per unit.*
- (f) *To schedule urgent hearing in the matter.*
- (g) *To consider the submission made by the Applicant and consider the same positively while deciding the Application.*
- (h) *To pass any other order / relief as the Hon'ble Commission may deem fit and proper in the facts and circumstances of the Case and in the interest of justice.*
- (i) *Condone any error / omission and to give opportunity rectify the same.*
- (j) *To permit the Applicant to make further submissions, addition and alteration to this Petition as may be necessary from time to time.*

2. I am directed to communicate that the hearing in the above matter will be held on **Wednesday, 31 October, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
