Subject: Petition of M/s Bengal Cardboard Industries & Printers Pvt. Ltd. under Section 86(1)(f) of the Electricity Act, 2003 pertaining to adjudication of disputes between M/s Bengal Cardboard Industries & Printers Pvt. Ltd. and Maharashtra State Electricity Distribution Company Limited

- **Case No. 229 of 2018**

M/s Bengal Cardboard Industries & Printers Pvt. Ltd. has submitted a Petition on 09.08.2018 under Section 86(1)(f) of the Electricity Act, 2003 pertaining to adjudication of disputes between M/s Bengal Cardboard Industries & Printers Pvt. Ltd. and Maharashtra State Electricity Distribution Company Limited.

The main prayers of the Petitioner are as under-

a) *Accept and allow this Petition;*

b) *Direct MSEDCL to comply with the terms of WEPA in letter and spirit including the obligation to make payment of the entire outstanding amount immediately towards Sales invoices due till date [a sum of Rs. 33,93,698/- (Rupees Thirty Three Lakh Ninety Three Thousand Six Hundred Ninety Eight only) is due up to the issued invoice dated 22.03.2018];*

c) *Direct MSEDCL to comply with the terms of WEPA in letter and spirit including the obligation to make payment of the entire outstanding amount immediately towards Delayed Payment Charge due till date [The DPC amount due up to the date May 25, 2018 is Rs. 10,04,683/- (Rupees Ten Lakh Four Thousand Six Hundred Eighty Three only)];*

d) *Direct MSEDCL to pay carrying cost at the rate of 15% per annum of the delay in payment of the Late/Delayed Payment Surcharge by MSEDCL;*

e) *Award cost of the petition in favour of the petitioner;*

f) *Direct MSEDCL to comply with the terms of WEPA by honoring its commitments under WEPA;*

g) *Call for the entire record relating to the case of Petitioner and after perusing the same, pass such appropriate order or direction;*

h) *Pass, any other appropriate relief, order or direction, which this Hon'ble Commission deems just and proper in the facts and circumstances of the present case, in favour of Petitioner.*

2. I am directed to communicate that the hearing in the above matter will be held on **Wednesday, 31 October, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.
3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondent before the scheduled date of hearing.
4. The Respondent is directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner.
5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
