- e) allow the Petitioner to revise the outstanding amount as reflected under Prayer (a) above, by considering the due date to be the 16th day from the date of joint meter reading;
- f) pass order for the cost of the instant legal proceedings in favour of the Petitioner as against the Respondent; and
- g) pass such other and further order or orders as this Hon'ble Commission may deem fit and proper under the facts and circumstances of the present case and in the interest of justice.
