

NOTICE

Subject: Petition of Suzlon Energy Limited for seeking refund / compensation for erecting evacuation infrastructure installed for connecting renewable energy project to the grid.

- **Case No. 228 of 2018**

Suzlon Energy Limited Maharashtra State Electricity Transmission Co. Ltd has submitted a Petition on 08.08.2018 under Section 86(1)(f) of the Electricity Act, 2003 R/W. Sections 86(1)(c), 86(1)(e) and other applicable provisions of the 2003 Act for seeking refund / compensation for erecting evacuation infrastructure installed for connecting renewable energy project to the grid.

The main prayers of the Petitioner are as under-

(a) *Direct the Respondent No. 2 to refund the expenditure incurred by the Petitioner towards installation and setting up of the evacuation infrastructure for the project, along with carrying cost / future interest admissible till the date of actual payment;*

(b) *Quash and set aside the letter dated 1.12.2014 written by the Director (Project), MSETCL;*

(c) *Without prejudice to prayer clauses (a) and (b), and in the alternative, clarify the scope of the 2008 Policy, 2009 Policy and the 2010 Policy on the subject of refund of the expenses incurred for setting up the evacuation infrastructure for renewable energy projects;*

(d) *Pass any other or further orders as may be necessary in the facts and circumstances of the case.*

2. I am directed to communicate that the hearing in the above matter will be held on **Tuesday, 13 November, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondents before the scheduled date of hearing.

4. The Respondents are directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
