The main prayers of the Petitioner are as under-

- A. *The respondent be punished for non-compliance of directions of the CGRF, Nashik in Case No.29/2017-18, Date of order: 02/02/2018, for contravention of as provided under Section 142 & Sec. 146 of The Electricity Act, 2003.*
- B. *The respondent be directed for the immediate compliance of order of C.G.R.F., Nashik in Case No.29/2017-18, Date of order: 02/02/2018.*
- C. *Suitable cost be imposed on the respondent considering the harassment to the petitioner and towards the burden of legal expenses.*
- D. *Other just and suitable orders be made in favor of petitioner.*
