Subject: Petition filed by M/s. Olam Agro India Private Limited under Section 142 and 146 of the Electricity Act, 2003 R/w Sections 62, 64 and 86 (1) (a) of the Act and in terms of the Orders passed by the Hon'ble MERC.

- **Case No. 233 of 2018**

M/s. Olam Agro India Private Limited has submitted a Petition on 14.08.2018 under Section 142 and 146 of the Electricity Act, 2003 R/w Sections 62, 64 and 86 (1) (a) of the Act and in terms of the Orders passed by the Hon'ble MERC.

The main prayers of the Petitioner are as under-

- (a) that it may be held that the Respondent No. 1 is guilty of contempt for willfully, knowingly and deliberately acting in contravention and contrary to the Order dated 02.05.2018 in Case No. 112 of 2017 passed by this Hon'ble Commission;*
- (b) The action of the Respondent No. 1 be intimated to / procedure adopted for intimation to the Hon'ble High Court, Bombay as deemed fit and proper for initiating the contempt procedure in respect of the contempt committed by them of the Order dated 02.05.2018 in Case No. 112 of 2017 passed by this Hon'ble Commission;*
- (c) pending the hearing and final disposal of this Contempt Petition the Respondent No. 1 be directed to forthwith purge the contempt of the Order dated 02.05.2018 in Case No. 112 of 2017 by holding in abeyance*
- (d) ad-interim relief in terms of prayer clause (c) above;*
- (e) The costs of this Petition be provided for;*
- (f) Such further orders as this Hon'ble Court may deem fit and proper be passed in favour of the Petitioner.*

2. I am directed to communicate that the hearing in the above matter will be held on **Thursday, 27 September, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondents before the scheduled date of hearing.

4. The Respondents are directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
