## - Case No. 246 of 2018

4. To allow the interim benefits not only prospectively but also retrospectively i.e. from the date of the tariff order dated 03.11.2016 and/or from any other date as may be deemed fit by this Hon'ble Commission.
5. To issue clarification in respect of para No. 43 of the aforesaid order dated 25.04 .2018 that prospectively means to implement the order from 16.06.2017 i.e. the date of filing of Case No. 99 of 2017 as the said M.A. No. 18 of 2017 was filed in Case No. 99 of 2017 and not from 25.04.2018 as is understood by the MSEDCL.
6. Pass such further order in favour of the Petitioner herein as this Hon'ble Commission may deem fit and proper in the interest of equity, justice and good conscience.
