Mahati Hydro Power Projects Private Limited has submitted a Petition on 21.08.2018 under Section 86(1)(f) of the Electricity Act, 2003 for seeking compliance of MSEDCL to meet start-up power requirement for its 2 X 2 MW Sonawade Small Hydro Electric Project through existing evacuation network and allow to continue the netting-off of start-up power against power supplied by Mahati Hydro Power Projects Private Limited from its Sonawade Small Hydro Electric Project according to the Energy Purchase Agreement and as per the MYT Order dated November 03, 2016 in Case No 48 of 2016 pronounced by this Hon'ble Commission.

The main prayers of the Petitioner are as under-

- a) To direct MSEDCL to continue to meet start-up power requirement through the existing evacuation infrastructure network and not to insist on separate connection for start-up power for the Power Plant.
- b) To direct MSEDCL to continue netting-off of start-up power supplied by MSEDCL to MHPPPL against the power supplied by MHPPPL to MSEDCL;
- c) To direct MSEDCL to refund Rs. 30,850/- (Rupees Thirty Thousand Eight Hundred and Fifty Only) paid by Petitioner for 20 kW start-up power connection in August 2010 along with interest @18% from the date of payment till realisation;
- d) To direct MSEDCL to comply with the MYT Order dated November 03, 2016 in letter and spirit;
- e) To direct Respondent to pay costs for the present Petition; and
- f) To pass such further order(s) as the Hon'ble Commission may deem just in the facts of the present case.
