Subject: Petition of Mrs. Aishwarya Rai Bachchan under Section 86(1)(f) of the Electricity Act, 2003 pertaining to adjudication of disputes between Mrs. Aishwarya Rai Bachchan and Maharashtra State Electricity Distribution Company Limited.

- **Case No. 256 of 2018**

Mrs. Aishwarya Rai Bachchan has submitted a Petition on 30.08.2018 for under Section 86(1)(f) of the Electricity Act, 2003 pertaining to adjudication of disputes between Mrs. Aishwarya Rai Bachchan and Maharashtra State Electricity Distribution Company Limited.

The main prayers of the Petitioner are as under-

a) *Accept and allow this Petition;*

b) *Direct MSEDCL to comply with the terms of WEPAs in letter and spirit including the obligation to make payment of the entire outstanding amount immediately towards Sales invoices due till date [a sum of Rs. 3,06,12,843/- (Rupees Three Crore Six Lakh Twelve Thousand Eight Hundred Forty Three only) is due up to the issued invoice dated April, 2018];*

c) *Direct MSEDCL to comply with the terms of WEPAs in letter and spirit including the obligation to make payment of the entire outstanding amount immediately towards Delayed Payment Charge due till date [The DPC amount due up to the date June 30, 2018 is Rs. 90,40,706/- (Rupees Ninety Lakh Forty Thousand Seven Hundred Six only)];*

d) *Direct MSEDCL to pay carrying cost at the rate of 15% per annum of the delay in payment of the Late/Delayed Payment Surcharge by MSEDCL;*

e) *Award cost of the petition in favour of the petitioner;*

f) *Direct MSEDCL to comply with the terms of WEPAs by honoring its commitments under WEPAs;*

g) *Call for the entire record relating to the case of Petitioner and after perusing the same, pass such appropriate order or direction;*

h) *Pass, any other appropriate relief, order or direction, which this Hon'ble Commission deems just and proper in the facts and circumstances of the present case, in favour of Petitioner.*

2. I am directed to communicate that the hearing in the above matter will be held on **Wednesday, 14 November, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
