

NOTICE

Subject: Petition of M/s. Krishna Valley Power Private Limited and Sahyadri Renewable Energy Private Ltd for non compliance of the Order of Hon'ble Commission, Order dated 15.01.2018 passed in Case No. 137 of 2017.

- **Case No. 260 of 2018**

M/s Green Infra Wind Energy Limited has submitted a Petition on 30.08.2018 under Section 142 & 149 of the Electricity Act, 2003 for non compliance of the Order of Hon'ble Commission, Order dated 15.01.2018 passed in Case No. 137 of 2017.

The main prayers of the Petitioner are as under-

a) *The Respondent be directed to obey the order Commission dated 15-01-2018 passed in Case No. 137 of 2017.*

b) *Thus, in case of SREPL (out of the 10,86,701 banked units lapsed after November 2016) 97,403 units be adjusted in February, 2017 of Glenmark and 4,05,219 units be adjusted in March, 2017 bill of Glenmark, and 5,84,079 units be purchased at applicable APPC tariff by MSEDCL, and the open access charges deducted on these surplus units (as calculated in Annexure I) be refunded back.*

c) *Also, in case of KVPPL (out of the 6,59,158 banked units lapsed after November, 2016) 2,00,937 units be adjusted in March 2017 bill of Derive Trading, and 4,58,221 units be purchased at applicable APPC tariff by MSEDCL, and the open access charges deducted on these surplus units (as calculated in Annexure I) be refunded back.*

d) *The Respondent and the concerned officers of the Respondent who ought to have obeyed the order; be punished for Non-compliance of the order of this Hon'ble Commission dated 15-01-2018 passed in Case No. 137 of 2017 by imposing highest penalty that can be levied u/s 142.*

e) *All other just and equitable reliefs be granted to the Petitioner for the effective adjudication of this case.*

2. I am directed to communicate that the hearing in the above matter will be held on **Wednesday, 14 November, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioners are directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondent before the scheduled date of hearing.

4. The Respondent is directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioners.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
