Subject: Petition of M/s Fabtech Projects & Engineers Limited under Section 142 & 146 for Non-Compliance of the DOA Regulations 2016 by MSEDCL and seeking directions for restoration of the Petitioner's Contract Demand for the billing month August 2016 and consequential reliefs from the MSEDCL.

- **Case No. 272 of 2018**

M/s Fabtech Projects & Engineers Limited has submitted a Petition on 20.09.2018 under Section 142 & 146 for Non-Compliance of the DOA Regulations 2016 by MSEDCL and seeking directions for restoration of the Petitioner's Contract Demand for the billing month August 2016 and consequential reliefs from the MSEDCL.

The main prayers of the Petitioner are as under-

- a) *The application may kindly be allowed.*
- b) *The Respondent be directed to restore the original Contract Demand of the petitioner i.e. 3800 KVA for the period from 01/08/2016 to 31/08/2016 for its HT Industrial Unit located in Solapur Circle.*
- c) *The Respondent be directed to pass on the consequential relief to the petitioner i.e. credit of the excess paid amount alongwith the applicable interest as per Section 62(6) in its ensuing energy bills.*
- d) *Proceedings under Section 142 and/or Section 146 be initiated against the Respondent for violation/contravention of DOA Regulations 2016.*
- e) *All other just and equitable reliefs be granted for the effective adjudication of the subject matter involved in this petition and for its implementation.*
