Subject: Petition of Laxmipati Balaji Supply Chain Management Limited for taking on record the deemed Distribution Licensee status of the Petitioner, Laxmipati Balaji Supply Chain Management Limited (“LBSCML”/Co-Developer”) for the Sector Specific SEZ and Information Technology (IT) SEZ being developed by Arshiya International Limited (“AIL”/”Developer”) at Village Sai, Taluka Panvel, Dist. Raigad, Maharashtra, and for issuing the Specific Conditions of Distribution License, as may be made applicable to the Petitioner.

- **Case No. 275 of 2018**

Laxmipati Balaji Supply Chain Management Limited has submitted a Petition on 26.09.2018 under Section 14, 16, 181 of the Electricity Act, 2003 and Regulation 8.16.2 the MERC (General Conditions of Distribution License) Regulations, 2006 for taking on record the deemed Distribution Licensee status of the Petitioner, Laxmipati Balaji Supply Chain Management Limited (“LBSCML”/Co-Developer”) for the Sector Specific SEZ and Information Technology (IT) SEZ being developed by Arshiya International Limited (“AIL”/”Developer”) at Village Sai, Taluka Panvel, Dist. Raigad, Maharashtra, and for issuing the Specific Conditions of Distribution License, as may be made applicable to the Petitioner.

The main prayers of the Petitioner are as under-

- i) *Admit the Present Petition*
- ii) *To take on record the Deemed Distribution Licensee status of the Petitioner, M/s Laxmipati Balaji Supply Chain Management Limited, under Section 14 of the Electricity Act, 2003 and Section 49 of SEZ Act, 2005 in terms of notifications dated 4 May, 2009, dated 5 April, 2010, 22 July, 2010 and 27 October, 2011 issued by the Ministry of Commerce & Industry (Department of Commerce), Govt of India.*
- iii) *To Issue Specific Conditions of Distribution License applicable to the Petitioner, M/s Laxmipati Balaji Supply Chain Management Limited.*
- iv) *To allow, the Petitioner to continue with the existing supply arrangement with MSEDCL for its consumers in its SEZ area, till the time Petitioner approaches the Hon'ble Commission in accordance with the provisions of MERC (Multi Year Tariff) Regulations, 2015.*
- v) *Condone any inadvertent omissions/ errors/ shortcomings and permit the Petitioner to add/ change/ modify/ alter this filing and make further submissions as may be required at a future date.*
- vi) *Pass such orders as the Hon'ble Commission may deem fit as per the facts of the present case.*

6. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
