Subject: Petition of Tata Power Company Limited Review in Case No 265 of 2018 dated 12th September, 2018 in the matter of Revision of transmission Tariff determined in Order dated 22<sup>nd</sup> July, 2016 in Case No. 91 of 2016 in pursuance of Mid-term Review process.

- **Case No. 361 of 2018**

Tata Power Company Limited has filed a Petition on 12.12.2018 Review in Case No 265 of 2018 dated 12th September, 2018 in the matter of Revision of transmission Tariff determined in Order dated 22nd July, 2016 in Case No. 91 of 2016 in pursuance of Mid-term Review process.

The main prayers of the Petitioner are as under-

- a) *To condone the delay of 45 days and admit the Tata Power-D Review Petition*
- b) *Allow the present Review Petition and Review its Order dated 12<sup>th</sup> September in Case No 265 of 2018 to the extent impugned by the Review Petitioner;*
- c) *Allow review of the Base Transmission Capacity Rights of Tata Power-D excluding demand of partial Open Access users for FY 2018-19 & FY 2019-20.*
- d) *Allow reduction of transmission charges, standby charges and MSLDC charges payable by Tata Power-D in terms of the erroneous computation of Base Transmission Capacity Rights of Tata Power-D for FY 2018-19 & FY 2019-20;*
- e) *Pass such other order(s) as this Hon'ble Commission may deem fit and proper in the facts and circumstances of the case.*
- f) *Condone any inadvertent omissions/ errors / rounding off differences / shortcomings and permit Tata Power- D to add / change / modify / alter this filing and make further submissions as may be required at a future date.*
