Subject: Petition of Maharashtra State Electricity Distribution Company Ltd. for seeking approval on adoption of Tariff for Long Term Procurement of 200 MW Solar Power through MSPGCL from the solar projects (Phase-I) to be set up under ‘ Mukhyamantri Sour Krishi Vahini Yojana’ to meet MSEDCL’s Solar Renewable Purchase Obligations.

- **Case No. 15 of 2019**

The Petitioner Maharashtra State Electricity Distribution Company Ltd. has filed on 15.1.2019 the Petition for seeking approval on adoption of Tariff for Long Term Procurement of 200 MW Solar Power through MSPGCL from the solar projects (Phase-I) to be set up under ‘ Mukhyamantri Sour Krishi Vahini Yojana’ to meet MSEDCL’s Solar Renewable Purchase Obligations.

I am directed to communicate that the hearing in the above matter will be held on **Friday, 08 February, 2019 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

The commission has directed to implead Maharashtra State Power Generation Co. Ltd as a Respondent in the matter.

1. The main prayers of the Petitioner are as under-

- a) *To admit the Petition as per the provisions under section 63 of Electricity Act (EA), 2003.*
- b) *To approve the Power Sale Agreement (PSA) document to be executed with MSPGCL.*
- c) *To accord approval for adoption of tariff of Rs.3.072 per Kwh for evacuation of Power at 11 KV level and Rs.3.05 per kWh for evacuation of power at 33 kV level for 25 years and signing of PSA with MSPGCL for 200 MW solar power projects under Mukhyamantri Sour Krishi vahini Yojna.*
- d) *To make eligible the power procured through these agreements for meeting the solar RPO requirement of MSEDCL.*
- e) *To Consider the submission made by the Petitioner and consider the same positively while deciding the petition as well as for further action;*
- f) *To pass any other order/relief as the Hon’ble Commission may deem fit and appropriate under the circumstances of the case and in the interest of justice;*
- g) *To condone any error/omission and to give opportunity to rectify the same;*
- h) *To permit the petitioner to make further submissions, addition and alteration to this petition as may be necessary from time to time.*

1. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Impleaded Parties before the scheduled date of hearing.

2. The Impleaded Parties are directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner.

3. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
