Subject: Petition filed by Maharashtra State Power Generation Company Limited (MSPGCL) for review of Order dated 24.10.2018 by Hon'ble Commission in Case No. 186 of 2018 (petition of MSEDCL to review certain issues in the Commission's Order dated 02.05.2018 in Case No. 111 of 2017), under Sections 85 of MERC (Conduct of Business) Regulations, 2004 and under Section 94 of the Electricity Act, 2003.

- **Case No. 364 of 2018**

Maharashtra State Power Generation Company Limited (MSPGCL) has filed a Petition on 13.12.2018 for review of Order dated 24.10.2018 by Hon'ble Commission in Case No. 186 of 2018 (petition of MSEDCL to review certain issues in the Commission's Order dated 02.05.2018 in Case No. 111 of 2017), under Sections 85 of MERC (Conduct of Business) Regulations, 2004 and under Section 94 of the Electricity Act, 2003.

- c) *Review the direction (2) given in the Order dated 24.10.2018 regarding the trimester-wise availability consideration and issue necessary modifications / clarifications considering practical difficulties of MSPGCL regarding planned overhaul/ outages;*
- d) *Condone any shortcomings/deficiencies in the petition and allow MSPGCL to submit additional information/data at a later stage as may be required; and*
- e) *Pass such further order(s) as it deems just, fit and proper in the facts and circumstances of the case.*
