Subject:- Petition of Ghatge Patil Industries Limited under provisions of the Electricity Act, 2003 and more particularly Section 42, Section 86(1)(e) and Section 86(1)(f) of the Electricity Act, 2003 pertaining to adjudication of disputes between Ghatge Patil Industries Limited and Maharashtra State Electricity Distribution Company Limited.
- **Case No. 22 of 2019**

Ghatge Patil Industries Limited has filed a Petition on 24.01.2019 Petition under provisions of the Electricity Act, 2003 and more particularly Section 42, Section 86(1)(e) and Section 86(1)(f) of the Electricity Act, 2003 pertaining to adjudication of disputes between Ghatge Patil Industries Limited and Maharashtra State Electricity Distribution Company Limited

The main prayers of the Petitioner are as under-

- a. *Direct MSEDCL to issue GCN for the 41,79,414 units injected into the grid from July 03, 2018 to July 31, 2018 within specified time and adjust in immediately ensuing bills of the Petitioner;*
- b. *Direct MSEDCL to pay the outstanding amount of Rs.43,05,539/- (Rupees Forty Three Lakh Five Thousand Five Hundred Thirty Nine only) towards DPC within specified time;*
- c. *Direct MSEDCL to pay carrying cost at the rate of 15% per annum on the delay in payment of DPC by MSEDCL as per Order dated March 16, 2017 passed in Case No. 68 of 2016;*
- d. *Award cost of these proceedings against MSEDCL and in favour of the Petitioner; and*
- e. *Pass such other orders as this Hon'ble Commission may deem just in the facts of the present case.*

4. The Respondent is directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
